OHIO BIRTH CERTIFICATE QUESTIONNAIRE

Introduction

As you may know, Ohio is one of only four states, plus Puerto Rico, that completely refuses to change the gender marker on birth certificates for transgender individuals.

We at the ACLU of Ohio and Lambda Legal have been working closely with our partners at the National Center for Transgender Equality (NCTE), TransOhio, Equality Ohio, Margie's Hope, and Equitas Health to change this discriminatory policy.

The most important thing we need right now is stories from people who have been directly harmed by this policy. Any information you choose to share with us will remain confidential between ACLU Ohio and Lambda Legal's legal staff.

The law is slow to catch up with society's needs. **Although we believe that Ohio's birth certificate policy is discriminatory, current law simply fails to provide recourse for the emotional and mental anguish this policy causes. That's why we must gather reports of very precise instances in which having to show your incorrect birth certificate compromised your safety or caused you a specific loss (e.g., caused you to be rejected for employment) or harm (e.g., cost you money or significant inconvenience).**

Please answer the following questions [on the next two pages] in as much detail as possible. We will not share any of your information without your consent.

This is not an offer of legal assistance, just a request for information. We will contact you only if we need to follow up with you.

January Board Meeting Report

Cathy was the meeting Facilitator.

Board members present: Vicky, Jeanne, Tina, Jill, Cathy, Stacy Lynn

Board members absent: Laura Ann

Guests present: none

The meeting was called to order at 7:44pm.

2018 Board Elections:

Nine ballots had been returned, two by mail and seven turned in at the Christmas party. They were counted and Tina received nine votes while everyone else received eight votes. There were no write-in votes. The new Board was seated for the 2018 calendar year.

Monthly Reports:

Cathy submitted the Minutes from the December 5th meeting. They were accepted.

Vicky reported on the PO Box. Two ballots had been returned by mail.

Stacy reported on the Hotline Phone. She submitted a report to the board. She spoke to two people about whether the Support Group was meeting on December 25, and spoke to one person about CrossPort's social events.

Vicky reported on Membership. She submitted a report to the board. As of the Board Meeting, CrossPort has six members who have paid dues for 2018.

Vicky reported on the Finances. She submitted a report to the board. As of November 30, 2017, there were two expenditures since that last board meeting, \$35.00 for the phone and \$149.48 more was spent on the Christmas party than it brought in. The bank balance totaled \$623.96.

Jeanne reported on the CrossPort Website. She continues to work on the new website in her spare time and feels about three full days of work remains. The CrossPort calendar from January through March has been updated.

Cathy reported on the Email Correspondence. She submitted a report. There was one request from WCPO for an interview regarding the Lakota School District not passing a transgender protection policy. There were three requests for information on CrossPort's social calendar and one request for peer support. Kathy S sent an email about attending the next CrossPort Board meeting. The average response time to email queries was less than 24 hours.

Tina reported on the CD/TS Peer Support Group. Four people were at the single meeting in December. She expects two more to attend that she met at the Reconnect party. They have started to collect emails from attendees to facilitate follow up.

Stacy reported on the Saturday Night Out. She submitted a report to the board. It was too close to Christmas and no one expressed interest in going.

Stacy reported on the First Friday Social. She submitted a report to the board. The January First Friday has not yet occurred. Tostados Grill is a very friendly environment and she expects a good turnout for next FFS.

Jill reported on the Library. There was no change from the previous month.

Stacy reported on Outreach. She submitted a report to the board. Stacy will concentrate on bringing new people into CrossPort. Jeanne volunteered to reach out to the other TG and allied groups in the Greater Cincinnati area, including VOG (Varieties of Gender) in Newtown, Heartland, GLSEN and Gender Bloc at UC. Vicky volunteered to be media contact as she has been interviewed on television in the past.

Cathy reported on the Newsletter. She submitted a report to the board. Cathy and Stacy met with the new editor, Meghan on December 22. It was decided at that time that the new version should have a table of contents on the first page and should always include the Board Minutes. The January issue should include the Board Election results.

Business advertising rates are to be \$36/year. Businesses whose ad is included in the January issue should be sent a solicitation to have it continue to appear for the next 11 issues.

Cathy also brought a first draft copy of the January issue to the Board. A proofreader should review each issue before it is sent out.

The Board voted 6-0 to make the InnerView available to all CrossPort members, not just the paying members.

Old Business:

Christmas Party. There was a 20 minute discussion on everything that went well and things that needed to be adjusted for the 2018 party. Planning to begin in April with estimated seating for up to 50. Will attempt to keep the price at \$40/person, or less if possible. Tickets will be sold in advance. It may be scheduled for the second Thursday rather than the third Thursday which would allow the regular social to be held in December as well.

Gangsters. As Laura Ann was not in attendance, there was no update from her about her attorney writing a letter to their management requesting the \$135 they owe us from the 2016 Christmas party.

New Business:

2018 Membership Drive. With the decision to send the InnerView to everyone, this causes CrossPort to shift to a donor membership model. A request for people to become donor or paying members will be posted on Facebook and printed in the newsletter as soon as the Paypal link on the CrossPort website is working.

Miscellany. Planning for summer events, i.e. the CrossPort picnic, should begin at the February meeting.

The meeting was adjourned at 10:03pm. The board agreed that Cathy should facilitate the February meeting.

It's Working!

If you are on Facebook, then you might have noticed that there is a LOT of sharing going on between local members of this community and extending well beyond our area. As a result, it looks like the community as a whole is more active and connected than it has been in a long time. As an example, this month's First Friday Karaoke at Tostados was very well attended with 17 Crossport related participants. Of course, it helped that it was Cathy's birthday, but still this was an impressive turn out.

The increase in participation is not just coincidental, but rather the result of efforts by the community to come together. So keep your eyes open for more opportunities and events.
